INTERNATIONAL ADMISSIONS: STATEMENT OF FINANCIAL SUPPORT

You are required to certify that you will have the sum of **US\$ 16,926** for your expenses for your first academic year at Fullerton College, exclusive of travel costs. You are also required to certify that you will be able to meet your expenses in future years of study if you expect your program to require more than one year. You should anticipate tuition increases in subsequent years. Students who plan to stay in the United States during the summer will need an additional US\$3,000.00 for living expenses for that three-month period. You will need bank certification that your parent or sponsor (cannot be another foreign student) has maintained an adequate balance for the past two years. Students who are sponsoring themselves are required to show funds for the duration of a 2-year college program.

While computing your expenses, you should bear in mind that on-campus employment is limited and F1 visa students cannot work off campus without authorization from the college and the US Citizenship and Immigration Services. Work authorization is not granted until after the student has been in the United States for 1 academic year and meets specific application criteria. Therefore, you should not look for income from employment, either part time or full time, to supplement your finances during the academic year. Dependents of F1 students are not permitted to work under any circumstances.
